

This new milestone in the incredible success story that Metis Child and Family Services has become is yet another model of excellence that will deepen the connection to our communities, families and citizens.



'New' seems to be the theme throughout the entire organization. Michif Child and Family Services were newly established, received its mandate and became operational in October, 2011. I was hired in May, 2012 as the incoming Executive Director and I am pleased to be serving the North. We have also had to hire new Executive Management and brought on board a lot more staff during this last year due to the growing number of families we serve.

Michif Child and Family Services have offices in Thompson, Swan River and Dauphin. The head office is located in The Pas. We also provide services to the surrounding areas. The purpose of this northern based Agency is to provide services specifically to Metis and Inuit children, youth and families. It was recognized that our needs were slightly different and unique in the North and addressing these issues has been the focus for the Agency.

At this time, I would like to acknowledge and thank those who have been instrumental in establishing Michif Child and Family Services as a separate Agency.

#### **Building Michif Quality Care:**

#### Community based care:

With our Vision, Mission and Guiding Principles as our foundation for service delivery, Michif Child and Family Services believes children are best protected by building on the strengths within our families and communities, and by supporting families and extended families within their communities.

Michif Child and Family Services have faced many challenges over our first year and has experienced many successes as well. We experienced significant growth in staff and service delivery and look forward to continued growth.

Michif CFS recognizes that each region within our Agency is unique and has endeavored to build our services to be reflective of the communities we serve.

The Parkland Region is the largest services provision area within MCFS. The Parkland Region provides ongoing family services and acts as the Designated Intake Agency (DIA) for the region, providing intake and after hours services. MCFS have offices in both Dauphin and Swan River to better meet the needs of the families and communities.

The Northern Region has offices in The Pas and Thompson. Each office houses its own unit and has a supervisor on site to allow for services to be offered and developed that meet the needs and challenges ofthose areas.

Michif Child and Family Services offer services such as family support. Support services may be provided to families to strengthen family functioning and prevent possible disruption. The program is designed to focus on the unique strengths and needs of each family, and supports the family by building on their strengths to address their needs and challenges to provide a safe environment for the children to remain in, or be returned to.

Being & new agency, MCFS has been given the opportunity to create and build our resources and alternative care program from the ground up. In our first year, we have seen this program grow and expand with much of our focus being on foster home recruitment and training, as well as the development of our Kinship Care Program throughout the Agency.

#### Differential Response:

Differential Response/Family Enhancement (DR/FE) means working with families in the early stages of involvement with the Child and Family Services System. Social Workers work closely with the families to involve them in a process that is designed to address the family's needs while keeping the children at home.

The pilot project in relation to our Designated Intake Agency ended in March, 2012. An external evaluation of the DR/FE Pilot Project was undertaken. The overall feedback we have received from the

families who participated in the project was positive, with most families stating they found the services helpful and would recommend it to others.

The Agency is now expanding the spirit of the program agency-wide by building on our prevention services offered to families through Family Enhancement. We are implementing the Signs of Safety Practice Model throughout the Agency at all levels of service and continue to use the Structured Decision Making assessment tools to help guide staff in decision making. The staff worked very hard this past year to continue to build on their skills in an effort to provide the best services to families possible and we applaud their efforts.

#### **Designated Intake Agencies:**

Michif Child and Family Services acts as the Designated Intake Agency for the Parkland Region. Our Intake and After Hours workers continue to work hard to provide timely and comprehensive responses to requests for service, despite the recurring challenges of work volumes and a large geographic area.

Our Intake workers have embraced the Structured Decision Making assessment tools and are also implementing Signs of Safety into their practice. For families who choose the Metis Authority, this will mean they will receive a more consistent and collaborative service right from the first contact.













## **March 31 CIC Information- Ages**
